 Report from Meeting of Presidents and Secretaries of Sections UEMS Brussels May 2004

The meeting and its results were discussed. Geriatric Medicine at the moment will not provide an European Exam but support the postgraduate academic courses implemented by EAMA. All new Member states of the EU have been contacted. The section will accept Israel as an observer as recommended by UEMS.
